**JOINT MOTION TO CONTINUE PRELIMINARY INJUNCTION  
HEARING AND ESTABLISH A BRIEFING SCHEDULE**

The Court has scheduled a December 29, 2020, hearing on Plaintiffs' motion for a preliminary injunction due to a Department of Public Health mandate that had a compliance deadline of December 31, 2020. The Department yesterday postponed the compliance deadline of that mandate to February 28, 2021. Counsel for the parties have conferred on a schedule and confirmed their availability for a hearing via Zoom. Therefore, to permit Defendants adequate time after the holidays to brief their opposition, to allow Plaintiffs to analyze that opposition and file a reply brief, and to give the Court a reasonable time to rule upon the Motion before the new effective date, the parties now jointly move the Court to continue the hearing and establish a briefing schedule as follows:

1. Defendants shall file and electronically serve their opposition to Plaintiffs' motion for a preliminary injunction by January 15, 2021.
2. Plaintiffs shall file and electronically serve their reply by January 22, 2021.

3. The Court shall hold a hearing on the Plaintiffs' motion on January 25, 26 or 27, 2021, via Zoom.
