Re: Studies Supporting the Claim That DTaP Does Not Cause Autism (IR#0247)

This firm represents the Institute for Autism Science (“IAS”) and the Informed Consent Action Network (“ICAN”). On behalf of IAS and ICAN, we are requesting records pursuant to the Freedom of Information Act (5 U.S.C. § 552, as amended) (“FOIA”).

All studies supporting the claim that DTaP does not cause autism.

Fees and charges for this search are to be waived pursuant to 5 U.S.C. § 552 (a)(4)(A)(iii) since IAS is a not-for-profit 501(c)(3) organization whose mission is to promote and publicly disseminate information regarding science related to the causes of and treatments for autism. As part of its mission, IAS actively supports and disseminates information related to scientific research and advancements in the field of autism related science. IAS is seeking the information in this FOIA request to allow it to contribute to the public understanding of the science underpinning some of the government’s autism claims. ICAN is also a not-for-profit 501(c)(3) organization and its mission is to raise public awareness about vaccine safety and provide the public with information to give informed consent. As part of its mission, ICAN investigates and disseminates information regarding vaccine safety, including through their website, and through press events and releases. ICAN is seeking the information in this FOIA request to allow it to contribute to the public understanding of the government’s vaccine safety programs, including the government’s efforts to promote vaccine safety. The information requested in this FOIA request will not contribute to any commercial activities.

Please note that the FOIA provides that if only portions of a requested file are exempted from release, the remainder must still be released. We, therefore, request that we be provided with all non-exempt portions which are reasonably segregable. We further request that you describe

any deleted or withheld material in detail and specify the statutory basis for the denial as well as your reasons for believing that the alleged statutory justification applies. Please also separately state your reasons for not invoking your discretionary powers to release the requested documents in the public interest. Such statements may help to avoid unnecessary appeal and litigation. IAS and ICAN of course reserve all rights to appeal the withholding or deletion of any information.

Access to the requested records should be granted within twenty (20) business days from the date of your receipt of this letter. Failure to respond in a timely manner shall be viewed as a denial of this request and IAS and ICAN may immediately file an administrative appeal.
