[IR#0690A] 22-00849 Documents reflecting all confirmed cases of a child 11 years of age or younger dying of COVID-19.

[IR#0689A] 22-00848 Documents reflecting all confirmed cases of a child 11 years of age or younger, without a pre-existing health condition, dying of COVID-19.
